Participant lists including name, country and institute of affiliation and role within the workshop are obtained from the workshops' individual websites or online booklets where available. Additional data (year PhD obtained, gender) are taken manually from national and institutional PhD thesis databases, and institutional, ORCID, LinkedIn, ResearchGate and other online profiles.

6. Transfer of personal data to a third country

Only the project scientists, based in the UK, Germany, Switzerland and the Netherlands, have access to the data. In case future studies would require access to the data, this will only be granted on the condition that all relevant scientific, ethical and legal standards are fully complied with. This includes, in particular, the protection of personal data and compliance with data protection regulations. Furthermore, the data is only made available within the framework of transparent and comprehensible procedures that ensure that its use is in line with the original research objectives.

7. Duration of storage of personal data

Data are stored on a General Data Protection Regulation compliant OneDrive folder from the University of Edinburgh during data processing and the publication process. Only the project scientists listed in 4. have access to this folder. The paper based on the data will present the data in an aggregated, anonymous and non-identifiable form. For at least 10 years after publication of the paper, the raw data will be stored in the University of Edinburgh's DataVault with access restricted to the project scientists. After these 10 years, the lead researcher of the study will assess if a further 10-year extension of data storage is required.
